We also develop a classifier that converts the web based correlation statistics into co refer or do not co refer decisions. The classifier is based on skylines and leverages the fact that the classification results are utilized in clustering. Our extensive experiments show that the proposed techniques have significant improvement over the state of the art approaches Entity resolution solutions often produce results consisting of objects whose attributes may contain uncertainty. This uncertainty is frequently captured in the form of a set of multiple mutually exclusive value choices for each uncertain attribute along with a measure of probability for alternative values. However the applications built on top of such data requires deterministic answers. Thus we propose a linear time algorithm that finds a deterministic answer set which maximizes the expected F\_ alpha measure of selection queries on top of such a probabilistic representation. The proposed solution gets near optimal results.
