Consider the following variables on the housing market:

- · Price: a house's selling price
- Lotsize: the size of a house's lot
- Space: the floor space of the house (in m²)
- Bidders: the number of bids the house received the last time it was sold
- · Bedroom: the number of bedrooms in a house
- Assess: the assessed value of a house, determined by an appraiser
- Suppose we are interested in a simple understanding of the marginal effects of various home characteristics on the selling price, write out the model you would want to estimate. Briefly explain (i) your model, and (ii) why you included (or didn't include) which of the variables! (10 points)
- Price is the dependent variable, 80 is the intercept and lotsize, space, bidders, bedrooms are independent variables in the model. We can leave the variable bidders out of the model, because this variable refers to the last time the house was sold and therefore, it should have no effect on the current sales price. There is no multicollinearity.
- ii) Therefore, we can exclude the variable bidders from the model which leads to → Price = 80 + 81*lotsize + 82*space + 83*bedrooms + 84*assess
- 2. Interpret the slope coefficient of the regression model $lnY_i = \beta_0 + \beta_2 lnX_i + u_i$ (2 points)

Functional form misspecification is happening, which cause the OLS estimators to be biased. It is also omitted omitted variable.

Furthermore, by getting rid of the inc ^2 you linearize the non-linear relationship between the variables. Also, without the X1^2 there is less flexibility in the modeling of the relationship between X1 'inc' and Y 'cons' and changes the marginal effect.
