



## Competition: Merger control procedures

This topic covers the European Merger Regulation ([Regulation \(EC\) No 139/2004](#), also known as the ECMR). The Merger Regulation provides the legal framework for the Commission's role in assessing the compatibility of mergers with the EU Treaty's competition rules. It also sets out the procedural aspects of the merger control process.

The Merger Regulation is part of the EU competition law.

The Commission's primary objective under the Merger Regulation is to ensure that the merging firms do not create a significant impediment to effective competition in the EU market. This is assessed on a case-by-case basis, taking into account the nature of the merger and the market conditions.

Under the Merger Regulation, the Commission has the power to approve, prohibit, or attach conditions to a merger. The Commission's decision is based on the following factors:

- The market power of the merging firms.
- The structure of the market.
- The likelihood of competition from other firms.
- The impact on consumers.

### Notifiable mergers

The Merger Regulation applies to mergers that are notifiable to the Commission. A merger is notifiable if it meets the following criteria:

- The turnover of the merging firms exceeds the thresholds set out in the Regulation.
- The market power of the merging firms is likely to be significant.
