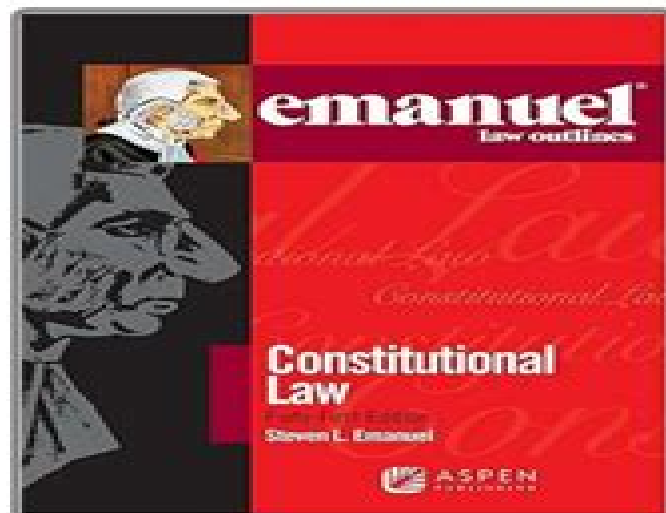

The Court rejected the independent state legislature theory which contended that a state legislature's power to regulate federal elections was absolute.
