

In the decades since the civil rights movement we ve made progress but not nearly as much as it might seem On the surface America's commitment to equal opportunity in the workplace has never been clearer Virtually every company has antidiscrimination policies in place and there are laws designed to protect these rights across a range of marginalized groups But as Ellen Berrey Robert L Nelson and Laura Beth Nielsen compellingly show this progressive vision of the law falls far short in practice When aggrieved individuals turn to the law the adversarial character of litigation imposes considerable personal and financial costs that make plaintiffs feel like they ve lost regardless of the outcome of the case Employer defendants also are dissatisfied with the system often feeling held up by what they see as frivolous cases And even when the case is resolved in the plaintiff's favor the conditions that gave rise to the lawsuit rarely change In fact the contemporary approach to workplace discrimination law perversely comes to reinforce the very hierarchies that antidiscrimination laws were created to redress Based on rich interviews with plaintiffs attorneys and representatives of defendants and an original national dataset on case outcomes Rights on Trial reveals the fundamental flaws of workplace discrimination law and offers practical recommendations for how we might better respond to persistent patterns of discrimination Statistical Methods in Discrimination Litigation D.
